Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in an Essential Plan was effective April 1, 2018?

Procedural History

On February 13, 2018, you submitted an application for financial assistance with health insurance.

On February 14, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost, effective March 1, 2018.

On February 20, 2018, you submitted an updated application for financial assistance with health insurance. That day, a preliminary determination was prepared, stating that you were eligible for the Essential Plan, effective April 1, 2018.

Also on February 20, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin March 1, 2018.

On February 21, 2018, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan, effective April 1, 2018.

Also on February 21, 2018. NYSOH issued a plan enrollment notice, based on your plan selection on February 20, 2018, stating that you were enrolled in an Essential Plan, and that your plan would start April 1, 2018.

On April 23, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted applications to NYSOH for financial assistance on February 13, 2018 and February 20, 2018.
- 2) You testified that you believed that you had completed your application and were enrolled in coverage on February 13, 2018.
- 3) According to your NYSOH account and your testimony, you enrolled in an Essential Plan on February 20, 2018.
- 4) You testified that you wanted your enrollment in an Essential Plan to begin on March 1, 2018, because you do not want to be penalized for a gap in coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42

CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective April 1, 2018.

You testified, and the record indicates, that you updated your NYSOH application on February 20, 2018. As a result, you were found eligible for the Essential Plan as of April 1, 2018. On February 20, 2018, you enrolled into an Essential Plan, with an April 1, 2018 start date. There is no indication in your NYSOH account, that you selected and were enrolled in an Essential Plan on February 13, 2018.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Since you selected an Essential Plan on February 20, 2018, your enrollment in that health plan properly took effect on the first day of the second month following February 2018; that is, on April 1, 2018.

Therefore, the February 21, 2018 plan enrollment notice stating that your enrollment in the Essential Plan was effective April 1, 2018, is correct and must be AFFIRMED.

Decision

The February 21, 2018 plan enrollment notice is AFFIRMED.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
