

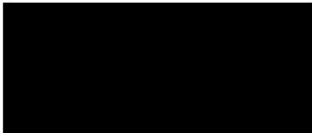

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan was effective no earlier than March 1, 2018?

Procedural History

On January 29, 2018, you applied to NYSOH for financial assistance with health insurance. Also on that date a preliminary eligibility determination was prepared stating that you were eligible for a full cost qualified health plan.

On January 31, 2018 you selected a qualified health plan.

On February 1, 2018, NYSOH issued a notice of eligibility determination stating that you were eligible for a full cost qualified health plan. This eligibility was effective March 1, 2018.

On February 1, 2018, NYSOH issued a letter confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$435.12, effective March 1, 2018.

On February 21, 2018, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination and enrollment confirmation notices insofar as they began your enrollment in a qualified health plan on March 1, 2018, and not February 1, 2018.

On April 24, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You applied to NYSOH for financial assistance on January 29, 2018.
- 2) You testified, and the record reflects, that you selected a qualified health plan on January 31, 2018.
- 3) Your enrollment in the plan became effective March 1, 2018.
- 4) You testified that you need your qualified health plan to begin on February 1, 2018 because you have medical bills from that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan was effective no earlier than March 1, 2018.

The record shows that January 29, 2018 you updated the information in your NYSOH account and on January 31, 2018 you submitted a request to enroll in a qualified health plan. On February 1, 2018, NYSOH issued an enrollment

confirmation notice stating that your enrollment in your qualified health plan was effective March 1, 2018.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

You testified that you selected your qualified health plan on January 31, 2018. As such, your enrollment properly took effect on the first day of the second following month; that is, on March 1, 2018.

Therefore, NYSOH's February 1, 2018 eligibility determination notice and February 1, 2018 enrollment confirmation notices are AFFIRMED because they properly began your enrollment in your qualified health plan on March 1, 2018.

Decision

The February 1, 2018 eligibility determination notice is AFFIRMED.

The February 1, 2018 enrollment confirmation notice is AFFIRMED.

Your enrollment in your qualified health plan properly began as of March 1, 2018. This decision does not change your eligibility.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This

must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
