Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for the Essential Plan with a \$20.00 monthly premium?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On February 21, 2018, you applied for health insurance and financial assistance through NY State of Health (NYSOH). That day, a preliminary eligibility determination was prepared stating that you were eligible to receive to enroll in the Essential Plan with a \$20.00 monthly premium, effective April 1, 2018.

Also on February 21, 2018, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you were not eligible for an increased amount of financial assistance.

On February 22, 2018, NYSOH issued an eligibility determination notice, consistent with the preliminary eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, effective April 1, 2018. The notice stated that you were not eligible for Medicaid because your annual household income was over the allowable income limit for that program. The notice further directed you to provide proof of income by May 22, 2018, to confirm your eligibility.

Also on February 22, 2018, a plan enrollment notice was issued confirming your enrollment in an Essential Plan with Vision and Dental, effective January 1, 2018.

On April 18, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and testimony, you expect to file your tax return for 2018 with a tax filing status of head of household. You will claim one dependent on that tax return.
- 2) You are seeking health insurance for yourself.
- 3) The application that was submitted on February 21, 2018, listed annual household income of \$25,920.00, consisting of earnings from your employment. You testified that your income could be slightly higher this year.
- 4) According to your NYSOH account and testimony, your income for February 2018 was \$2,160.00.
- 5) According to your NYSOH account and testimony, you will not be taking any deductions on your 2018 tax return.
- 6) According to your NYSOH account and testimony, you live in Monroe County, NY.
- 7) You testified that the cost of the Essential Plan and the cost of its co-pays are a financial burden to you and you need more financial assistance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to

have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Federal Register 8831).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2018 FPL, which is \$16,460.00 for a two -person household (83 Fed. Reg. 2642).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined you to be eligible for the Essential Plan with a \$20.00 monthly premium.

The application that was submitted on February 21, 2018, listed an annual household income of \$25,920.00 and the eligibility determination relied upon that information.

According to your NYSOH account and testimony, you expect to file your tax return for 2018 with a tax filing status of head of household. You will claim one dependent on that tax return. Therefore, for purposes of these analyses, you are in a two-person household.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since an annual household income of \$25,920.00 is 159.61% of the 2017 FPL, NYSOH correctly found you to be eligible for the Essential Plan with a \$20.00 monthly premium.

The second issue under review is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,460.00 for a two-person household. Since \$25,920.00 is 157.47% of the 2018 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

According to your NYSOH account and testimony, your income for February 2018 was \$2,160.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,893.00 per month. Since you credibly testified, and your application states, that you earned \$2,160.00 in February 2018, you do not qualify for Medicaid based on monthly income as of the date of your application.

Since the February 21, 2018 eligibility determination notice properly stated that, based on the information you provided, you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, it is correct and is **AFFIRMED**.

Finally, it is noted that your February 22, 2018 eligibility determination notice was conditional pending submission of your proof of income by May 22, 2018. However, the record indicates that you have been disenrolled from your Essential Plan for non-payment of premium as of April 1, 2018. As such, no further action is required of NYSOH at this time.

Decision

The February 22, 2018 eligibility determination notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

You remain conditionally eligible for the Essential Plan with a \$20.00 monthly premium.

You are ineligible for Medicaid.

This decision does not affect any subsequent eligibility determinations made by NYSOH.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.
