NOTICE OF DISMISSAL

On February 21, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination notice, stating that you were eligible to enroll in an Essential Plan with a \$20.00 monthly premium and your spouse was eligible to enroll in a full pay qualified health plan through NYSOH, effective April 1, 2018. You appealed this determination.

On April 2, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 24, 2018, at 3:00 p.m..

A Hearing Officer called you at 3:00 p.m. on April 24, 2018. You answered the call and stated that you were no longer interested in pursuing the appeal because the issue had been resolved to your satisfaction. However, you were unable to be sworn in and withdraw your appeal under oath because you were busy.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
