Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your children's enrollment in their Child Health Plus plan was effective April 1, 2018?

Procedural History

On December 22, 2017, you submitted an application for health insurance for your children.

On December 23, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your December 22, 2017 application, stating that your children were eligible to enroll in Child Health Plus, effective February 1, 2018. This notice directed you select a health plan for enrollment for your children.

On February 23, 2018, you contacted NYSOH and selected a Child Health Plus plan for enrollment for your children.

Also on February 23, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health plus plan insofar as it did not begin February 1, 2018.

On February 24, 2018, NYSOH issued a notice of enrollment, based on your plan selection on February 23, 2018, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start April 1, 2018.

On April 13, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your children's enrollment start date. You are seeking for their Child Health Plus plan to begin as of February 1, 2018 because your children have outstanding medical bills for February 2018 and March 2018.
- 2) You testified that you submitted an application for health insurance for your children on December 22, 2017 and received a message that they had been approved for coverage. You testified that the system did not tell you that you needed to select a plan for enrollment.
- 3) You testified that you believe you have selected to receive notices from NYSOH via regular mail and not e-mail alerts.
- 4) Your NYSOH account reflects that you have elected to receive e-mail alerts from NYSOH.
- 5) On December 23, 2017, NYSOH mailed you a notice indicating that you had selected to get all information from NYSOH via e-mail. This notice explained that all notices about eligibility and coverage will be in your NYSOH account and that you would be notified of any changes to your account via e-mail and that you must log into your account to read your notice.
- 6) You testified that you did not receive the December 23, 2017 eligibility determination notice advising you that your children were eligible for Child Health Plus and that you needed to select a health plan for enrollment for your children.
- 7) You testified that you did receive an e-mail alert from NYSOH which directed you to log-in to your NYSOH account.
- 8) You testified that you called NYSOH in December 2017 and again in January 2018 to make sure that your children's coverage was set.
- 9) During the hearing, you gave permission for the Hearing Officer to listen to recordings of phone calls you had with NYSOH.

10) There is no indication that you placed any calls to NYSOH prior to February 23, 2018.

11) On February 23, 2018, you contacted NYSOH and enrolled your children into a Child Health Plus plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see *e.g.* State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective April 1, 2018.

You submitted an application for health insurance for your children on December 22, 2017. You did not select a plan for enrollment for your children at that time.

You testified that you did not receive the December 23, 2017 eligibility determination notice from NYSOH directing you to pick a health plan for enrollment for your children. However, the record reflects that you have elected to receive e-mail alerts from NYSOH regarding notices. Additionally, you testified that you received an e-mail alert on December 23, 2017, which directed you to log-in to your NYSOH.

Therefore, the record reflects that NYSOH properly notified you that you needed to select a Child Health Plus plan for enrollment for your children.

The record reflects that you contacted NYSOH on February 23, 2018 and enrolled your children into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you selected a Child Health Plus plan for your children on February 23, 2018, there enrollment properly began on the first day of the second month following February 23, 2018; that is, on April 1, 2018.

Therefore, the February 24, 2018 enrollment confirmation notice stating that your children's enrollment in their Child Health Plus plan was effective April 1, 2018, is correct and must be AFFIRMED.

Decision

The February 24, 2018 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is April 1, 2018.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
