NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 18, 2018, NY State of Health (NYSOH) issued a notice stating your oldest child was conditionally eligible for Medicaid. You appealed that notice. On March 7, 2018, you requested to withdraw this appeal. However, on March 19, 2018, you requested to reinstate your appeal based on a March 20, 2018 eligibility determination notice stating you were eligible for a limited time to receive up to \$425.00 per month in advance payments of the premium tax credit, and cost-sharing reductions, effective May 1, 2018. NYSOH reinstated your first appeal, but also created a second appeal number for your new appeal.

On March 26, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 18, 2018, at 11:00 AM.

On April 18, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 11:00 AM, 11:15 AM, and 11:30 AM, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
