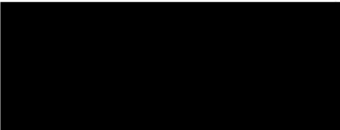

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were enrolled in a dental plan with an enrollment start date of April 1, 2018?

Procedural History

On September 30, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective as of November 1, 2017.

On November 2, 2017, NYSOH issued an enrollment notice confirming that as of November 1, 2017, you were enrolled in an Essential Plan, without dental coverage, with an enrollment start date of October 1, 2017.

On February 26, 2018, you spoke to NYSOH's Account Review Unit and requested an appeal insofar as the enrollment start date of your dental plan coverage.

On February 27, 2018, NYSOH issued an enrollment notice confirming that as of February 26, 2018, you were enrolled in an Essential Plan, with dental coverage, with an enrollment start date of April 1, 2018.

On April 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking to be enrolled in a dental plan with an enrollment start date of March 1, 2018.
- 2) According to your NYSOH account, on September 30, 2017, you were enrolled in an Essential Plan, without dental coverage, with an enrollment start date of October 1, 2017.
- 3) You testified that a representative from the health insurance company stated that if you selected a dental plan before the end of a month, it would be effective on the first day of the following month.
- 4) According to your NYSOH account, on February 26, 2018, you enrolled in dental coverage.
- 5) You testified that on February 26, 2018, the NYSOH representative stated that your dental coverage would not be effectuated until April 1, 2018.
- 6) On February 27, 2018, NYSOH issued an enrollment notice confirming that you were enrolled in dental coverage with an enrollment start date of April 1, 2018.
- 7) You testified that you went to a dental appointment on or around [REDACTED]
- 8) You testified that you incurred dental expenses from the [REDACTED] appointment and want to be reimbursed for those expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR §

155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Stand-Alone Dental Plans

If a stand-alone dental plan is offered through NYSOH, NYSOH must not fail to treat the dental plan as QHP solely because the plan does not offer the same coverage of benefits (45 CFR §155.1065(a), (d)).

QHP Enrollment Start Date

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were enrolled in a dental plan with an enrollment start date of April 1, 2018.

On September 30, 2017, you were enrolled in an Essential Plan, without dental coverage, with an enrollment start date of October 1, 2017. You testified that a representative from the health insurance company stated that if you selected a dental plan before the end of a month, it would be effective on the first day of the following month.

On February 26, 2018, you enrolled in dental coverage. You testified that the NYSOH representative informed you that your dental coverage would not be effectuated until April 1, 2018. On the following day, NYSOH issued an enrollment notice confirming that you were enrolled in dental coverage with an enrollment start date of April 1, 2018.

You testified that you incurred dental expenses because you opted to go to a dental appointment on or around [REDACTED]. The record reflects that any miscommunication with the enrollment start of your dental coverage was clarified as of February 26, 2018.

The date on which a QHP or dental coverage can take effect depends on the day a person selects the plan for enrollment. If the plan is selected from the first day to the fifteenth day of a month, the plan is effective on the first day of the

following month. If the plan is selected from the sixteenth day of the month to the end of the month, the plan is effective on the first day of the second following month.

The credible record reflects that you enrolled in dental coverage as of February 26, 2018. Therefore, your coverage should be effectuated the first day of the second following month; that is April 1, 2018.

The February 27, 2018 enrollment notice is AFFIRMED.

Decision

The February 27, 2018 enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your dental coverage properly began as of April 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
