NOTICE OF DISMISSAL

On February 27, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to receive up to \$372.00 and cost-sharing reductions, effective April 1, 2018. You appealed this determination.

On March 8, 2018, NYSOH issued a notice stating that, for a limited time, you were eligible for the Essential Plan with a \$20.00 monthly premium, effective March 1, 2018. This was because you had been granted Aid to Continue pending the outcome of your appeal.

On April 3, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 27, 2018, at 10:00 AM.

A Hearing Officer called you at 10:00 AM, 10:15 AM and 10:17 AM at the telephone number provided in your NYSOH account and listed in the Notice of Hearing. Although you answered the call at 10:17 AM, you stated that your issue had been resolved, would not identify yourself to the Hearing Officer and disconnected the call. The Hearing Officer called you back at 10:20 AM, but was unable to reach you.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
