NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 28, 2018, NY State of Health (NYSOH) issued an enrollment confirmation notice stating that you would be enrolled in the Essential Plan, effective April 1, 2018. You appealed this determination insofar as your coverage did not begin on March 1, 2018.

On March 28, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 24, 2018, at 1:00pm.

On April 24, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you. You stated that you were not prepared to proceed with your hearing at that time because you were at work. You agreed to reschedule your hearing for May 4, 2018 at 2:00pm.

On May 4, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 2:00pm, 2:15pm and 2:30pm, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
