

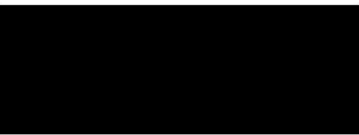

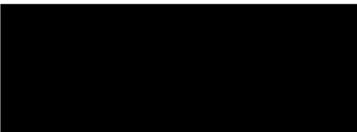

## **Decision**

## **Issues**

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you and your adult children were eligible for the Essential Plan?

Did NY State of Health properly determine that you and your adult children were not eligible for Medicaid?

## **Procedural History**

On February 16, 2018, you applied for health insurance and financial assistance through NY State of Health (NYSOH) for yourself and your two adult children.

On February 17, 2018, NYSOH issued an eligibility determination notice stating that you and your two adult children were eligible to enroll in the Essential Plan, effective April 1, 2018. That notice also stated that you and your adult children were not eligible for Medicaid because your annual household income was over the allowable income limit for that program.

On February 27, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you and your adult children were not eligible for Medicaid.

On April 19, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to May 4, 2018, to allow you time to submit copies of your and your

spouse's 2018 Social Security benefit letters, as well as proof of your adult daughter's 2018 income.

As of May 4, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2018 with a tax filing status of married filing jointly. You will claim three dependents on that tax return.
- 2) You are seeking Medicaid coverage for yourself and your two adult children.
- 3) The application that was submitted on February 16, 2018 listed annual household income of \$41,954.00, consisting of \$4,548.00 you receive in Social Security disability benefits, \$18,854.00 your spouse receives in pension income and \$18,552.00 your spouse receives in Social Security disability benefits. You testified that this amount was correct at the time you applied.
- 4) You testified that your adult daughter, who you intend to declare as a tax dependent, began working full-time at [REDACTED] in April 2018. She expects her employment to continue for the remainder of the year.
- 5) You further testified that your son, for whom you are also seeking coverage, is a full-time student and has no income.
- 6) You testified that your monthly income for February, 2018 was \$3,496.00, including the total amount your husband receives from Social Security each month prior to deductions for his Medicare coverage.
- 7) You did not provide copies of your or your spouse's 2018 Social Security benefit award letters.
- 8) Your application states that you will not be taking any applicable deductions on your 2018 tax return.
- 9) Your application states that you live in [REDACTED].

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$28,780.00 for a five-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the

applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2018 FPL, which is \$29,420.00 for a five-person household (83 Fed. Reg. 2642).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you and your two adult children were eligible for the Essential Plan.

The application that was submitted on February 16, 2018 listed an annual household income of \$41,954.00 and the eligibility determination relied upon that information.

You and your two adult children are in a five-person household. You expect to file your 2018 income tax return as married filing jointly and will claim three children as dependents on that tax return.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$28,780.00 for a five-person household. Since an annual household income of \$41,954.00 is 145.77% of the 2017 FPL, NYSOH correctly found you and your two adult children to be eligible for the Essential Plan.

The second issue under review is whether NYSOH properly determined that you and your two adult children were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$29,420.00 for a five-person household. Since \$41,954.00 is 142.6% of the 2018 FPL, NYSOH properly found you and your adult children to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the 2018 FPL, which is \$3,384.00 per month for a five-person household.

During the hearing, you were asked to submit copies of your and your spouse's 2018 Social Security benefit award letters as well as documentation of how much your oldest daughter received from her job. No documentation was submitted. However, you testified that your household earned at least \$3,496.00 in February 2018. Since \$3,496.00 is over the allowable Medicaid limit of \$3,384.00 per month for a five-person household, you and your adult children do not qualify for Medicaid based on a monthly income basis as of the date of your application.

Since the February 17, 2018 eligibility determination notice properly stated that, based on the information you provided, you and your two adult children were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is **AFFIRMED**.

## **Decision**

The February 17, 2018 eligibility determination notice is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

You and your adult children are eligible for the Essential Plan.

You and your adult children are ineligible for Medicaid.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the

dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
