## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On February 17, 2018, NY State of Health (NYSOH) issued an enrollment notice confirming that as of February 16, 2018, your children were enrolled in a Child Health Plus plan with an enrollment start date of April 1, 2018. You requested an appeal insofar as the enrollment start date of that health plan.

On March 27, 2018, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was scheduled for April 19, 2018, at 1:00 pm.

On April 19, 2018, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you three times between 1:00 pm and 1:30 pm, using the telephone number you provided to NYSOH. However, there was no answer.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
