Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan, with United Healthcare, was effective April 1, 2018?

Procedural History

On February 22, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your February 21, 2018 application, stating that you are eligible to enroll in the Essential Plan, effective February 1, 2018.

Also on February 22, 2018, NYSOH issued a notice of enrollment, based on your plan selection on February 21, 2018, stating that you were enrolled in an Essential Plan with Fidelis Care, effective February 1, 2018.

On February 28, 2018, you spoke to NYSOH's Account Review Unit and appealed the April 1, 2018 start date of your enrollment in the Essential Plan insofar as your coverage with United Healthcare could not be backdated to February 1, 2018.

On March 1, 2018, NYSOH issued a notice of eligibility determination, based on your February 28, 2018 application, stating that you were eligible to enroll in the Essential Plan, effective April 1, 2018.

Also on March 1, 2018, NYSOH issued a notice of enrollment, based on your plan selection on February 28, 2018, stating that you were enrolled in an

Essential Plan with United Healthcare, and that your plan would start April 1, 2018.

Finally, on March 1, 2018, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan with Fidelis Care would end March 31, 2018.

On April 30, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance, with the assistance of a certified application counselor, on February 21, 2018.
- 2) The record reflects, that your certified application counselor enrolled you in an Essential Plan with Fidelis Care on February 21, 2018.
- 3) You testified that you went to the doctor for [REDACTED] on [REDACTED] [REDACTED] and later found out that your doctor's office did not accept your Fidelis Care plan.
- 4) You testified that once you determined which plan your doctor accepted you contacted the NYSOH to change plans.
- 5) You testified, and the record reflects, that you enrolled in an Essential Plan with United Healthcare on February 28, 2018.
- 6) You testified that you wanted your enrollment in United Healthcare to begin on February 1, 2018 in order to cover the unpaid medical bill incurred in February.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan with United Healthcare was effective April 1, 2018.

You testified, and the record indicates, that you updated your NYSOH application on February 21, 2018. As a result, you were found eligible for the Essential Plan as of February 1, 2018 and enrolled into a plan with Fidelis Care that day.

You testified that you switched plans on February 28, 2018 because your doctor's office did not accept your plan. You testified that you needed your United Healthcare plan to be backdated to February 1, 2018 to cover your unpaid medical bill. However, the date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On February 28, 2018, you selected an Essential Plan with United Healthcare, so your enrollment properly took effect on the first day of the second month following February; that is, on April 1, 2018.

Therefore, the March 1, 2018 enrollment confirmation notice stating that your enrollment in an Essential Plan with United Healthcare was effective April 1, 2018, is correct and must be **AFFIRMED**.

Decision

The March 1, 2018 enrollment confirmation notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your enrollment in an Essential Plan with United Healthcare is April 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
