#### Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that your son was eligible for the Essential Plan?

Did NY State of Health properly determine that your son was not eligible for Medicaid?

# **Procedural History**

On January 24, 2018, you applied for health insurance and financial assistance through NY State of Health (NYSOH) on behalf of your son.

On January 25, 2018, NYSOH issued an eligibility determination based on the January 24, 2018, application, stating that your son was eligible to enroll in the Essential Plan, effective March 1, 2018. That notice also stated that your son was not eligible for Medicaid because his annual household income was over the allowable income limits for that programs.

On March 1, 2018, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as your son was not eligible for Medicaid.

On April 26, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## Findings of Fact

A review of the record supports the following findings of fact:

- You testified that you expect to file your tax return for 2018 with a tax filing status of head of household. You will claim your son as a dependent on that tax return.
- You are seeking insurance for your son.
- 3) The application that was submitted on January 24, 2018 listed annual household income of \$25,298.00, consisting of \$25,298.00 you earn from your employment. You testified that this amount was correct.
- 4) You testified that your monthly income for January, 2018 was \$2,361.00.
- 5) On the date of your application, your son was
- Your application states that you will not be taking any deductions on your 2018 tax return.
- 7) Your application states that you live in Monroe County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

#### <u>Medicaid</u>

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

A child aged 19 or 20, whose primary residence is with their parents, is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 155% of the federal poverty level (FPL) for the applicable family size (NY Social Services Law § 366(b)(7); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2018 FPL, which is \$16,460.00 for a two-person household (83 Fed. Reg. 2642).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size

(42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

# Legal Analysis

The first issue under review is whether NYSOH properly determined that your son was eligible for the Essential Plan, effective March 1, 2018.

The application that was submitted on January 24, 2018 listed an annual household income of \$25,298.00, and the eligibility determination relied upon that information.

Your son is in a two-person household. You expect to file your 2018 income tax return as head of household and will claim your son as your only dependent on that tax return.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since an annual household income of \$25,298.00 is 155.78% of the 2017 FPL, NYSOH correctly found your son to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that your son was not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 20 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 155% of the FPL for the applicable family size.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that that your gross income for January 2018 was \$2,361.00.

To be eligible for Medicaid, your son would need to meet the non-financial criteria and have an income no greater than 155% of the FPL, which is \$2,127.00 per month. Since you testified that you earned \$2,361.00 in January 2018, your son does not qualify for Medicaid based on monthly income as of the date of your application.

Since the January 25, 2018 eligibility determination notice properly stated that your son was eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

#### Decision

The January 25, 2018 eligibility determination notice is AFFIRMED.

# **How this Decision Affects Your Eligibility**

Your son is eligible for the Essential Plan.

Your son is ineligible for Medicaid as of January 25, 2018.

# If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
