Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did the NY State of Health properly determine that your newborn's eligibility for Child Health Plus and enrollment in his Child Health Plus plan were effective April 1, 2018?

Procedural History

On February 28, 2018, NY State of Health (NYSOH) issued an eligibility determination notice, based on your February 27, 2018 application, stating that your newborn was eligible to enroll in Child Health Plus for a limited time, effective April 1, 2018. You were directed to provide proof of household income for your newborn by April 28, 2018.

Also on February 28, 2018, you uploaded income documentation.

Also on February 28, 2018, NYSOH verified your documentation as sufficient proof of income and an application was run on your behalf.

On March 1, 2018, NYSOH issued an eligibility determination notice stating that your newborn was fully eligible for Child Health Plus with a \$60.00 per month premium, effective April 1, 2018.

Also on March 1, 2018, NYSOH issued a plan enrollment notice stating that your newborn was enrolled in a Child Health Plus plan, and that this enrollment in the plan would start April 1, 2018.

On March 2, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your newborn's Child Health Plus plan insofar as it did not begin his date of birth, or in the alternative, on [REDACTED].

On May 7, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified that you are seeking for your newborn's Child Health Plus plan to begin as of his date of birth, or in the alternative, [REDACTED]. You testified that your newborn has had to undergo medical treatment since his birth, for which you have paid out of pocket.
- 2) You testified that your newborn was born on [REDACTED].
- 3) Your NYSOH account indicates that you first updated your account to add your newborn on February 27, 2018.
- 4) On February 28, 2018, you uploaded your household's income documentation to your NYSOH account.
- 5) On February 28, 2018, NYSOH reviewed the income documentation you submitted and determined this to be sufficient proof of your household's income.
- 6) An application was run on your behalf on February 28, 2018, and your newborn was determined fully eligible for Child Health Plus, effective April 1, 2018.
- 7) Your NYSOH account indicates that your newborn was enrolled in a Child Health Plus plan on February 28, 2018, with an April 1, 2018 start date.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Child Health Plus – Newborns

A newborn child who is eligible for Child Health Plus shall be enrolled retroactively to the first day of the month in which the child is born, provided that the applicant submitted a completed application and required information and documentation within sixty days of the child’s birth (NY Public Health Law §2511(2)(i)(i), effective January 1, 2017).

Legal Analysis

The issue under review is whether NYSOH properly determined that your newborn’s eligibility for Child Health Plus and enrollment in his Child Health Plus plan began on April 1, 2018.

The record reflects that you contacted NYSOH on February 27, 2018 and submitted an application for financial assistance with health insurance for your newborn. Your newborn was enrolled into a Child Health Plus plan on February 28, 2018.

In the case of newborns born after January 1, 2017, the newborn will be enrolled retroactively to the first day of the month in which the child was born, provided that the applicant submits a completed application and required information and documentation within sixty (60) days of the child's birth.

The record reflects that your newborn was born on [REDACTED] [REDACTED] [REDACTED]. Sixty days from that date is [REDACTED]. You submitted an application for health insurance on February 27, 2018, which is more than 60 days from the child's birth. Therefore, your child is not eligible for retroactive enrollment in his Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person is enrolled into a plan. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As your newborn was enrolled into a Child Health Plus plan on February 28, 2018, his Child Health Plus plan properly began on the first day of the second month following February 2018; that is, on April 1, 2018.

Therefore, the March 1, 2018 eligibility determination notice and the March 1, 2018 plan enrollment notice are AFFIRMED as they properly began your newborn's eligibility for Child Health Plus and enrollment in his Child Health Plus plan as of April 1, 2018.

Decision

The March 1, 2018 eligibility determination notice is AFFIRMED.

The March 1, 2018 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your newborn's eligibility for Child Health Plus and enrollment in his Child Health Plus plan properly began on April 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
