NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 2, 2018, NY State of Health (NYSOH) issued a notice of disenrollment stating your children's Child Health Plus coverage was terminated, effective December 31, 2017. You appealed the end date of that coverage.

On April 19, 2018, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for May 14, 2018, at 10:00 a.m.

On May 14, 2018, a Hearing Officer called you at the telephone number you provided to NYSOH, at 10:00 a.m., wherein you answered and indicated that your spouse was representing you at the hearing and you requested that she be called directly. The Hearing Officer placed three calls to your spouse at the telephone number you provided, [REDACTED] at 10:17 a.m., 10:30 a.m., and 10:40 a.m., but was unable to reach your spouse.

Since neither you nor your representative appeared for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
