

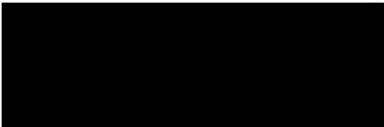

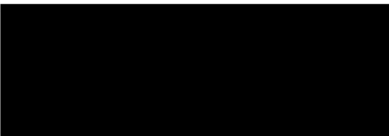

Issues

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were eligible to receive up to \$347.00 per month in advance payments of the premium tax credit, as well as cost-sharing reductions, effective April 1, 2018?

Procedural History

On March 5, 2018, you submitted an updated application for financial assistance with health insurance through NY State of Health (NYSOH). That day, a preliminary eligibility determination was prepared with regard to that application stating that you were eligible to receive up to \$347.00 in advance payments of the premium tax credit (APTC) and cost-sharing reductions, effective April 1, 2018.

Also on March 5, 2018, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you were not eligible for an increased amount of financial assistance.

On March 6, 2018, NYSOH issued an eligibility redetermination notice, based on the March 5, 2018 application, stating that you were eligible to receive up to \$347.00 in APTC, as well as cost-sharing reductions if you enrolled in a silver level qualified health plan, both effective April 1, 2018. That notice also stated, in part, that you were not eligible for the Essential Plan because your annual household income was over the allowable income limit of \$24,120.00 for that program.

On May 3, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking, specifically, to be found eligible to enroll in the Essential Plan.
- 2) You testified that you expect to file your tax return for 2018 with a tax filing status of head of household. You will claim one dependent on that tax return.
- 3) You are seeking insurance for yourself.
- 4) The application that was submitted on March 5, 2018 listed annual household income of \$27,560.00, consisting of employment income earned at a rate of \$13.25 per hour over a 40-hour workweek. You testified that this amount was correct to your knowledge at the time, but that you received a raise sometime in February 2018 that you were not aware of on March 5, 2018. You further testified that your new expected annual household income was \$29,577.60, consisting of employment income earned at a rate of \$14.22 per hour over a 40-hour workweek.
- 5) Your application states that you will not be taking any deductions on your 2018 tax return.
- 6) You testified, and your application states, that you live in Westchester County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible

for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Federal Register 8831).

For annual household income in the range of at least 200% but less than 250% of the 2017 FPL, the expected contribution is between 6.34% and 8.10% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year

for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Household Composition

For purposes of APTC and cost-sharing reductions, the household size equals the number of individuals for whom the taxpayer is allowed a deduction under 26 USC § 151 for the taxable year, which typically includes: (1) the taxpayer, (2) his or her spouse, and (3) any claimed dependents (26 USC § 36B(d)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined you to be eligible for an APTC up to \$347.00 per month as well as cost-sharing reductions.

The application that was submitted on March 5, 2018 listed an annual household income of \$27,560.00 and the eligibility redetermination relied upon that information.

For purposes of APTC, the household size of a taxpayer equals the number of individuals for whom the taxpayer is allowed a deduction including the taxpayer and any claimed dependents. Your March 5, 2018 application states and you confirmed that you expect to file your tax return for 2018 with a tax filing status of head of household. You will claim one dependent on that tax return. Therefore, you are in a two-person household.

The preliminary eligibility determination prepared on March 5, 2018 states that your annual household income results in a FPL of 228.52%; as a result, you were found eligible for \$347.00 in APTC and cost-sharing reductions.

However, an annual income of \$27,560.00 is 169.70% of the 2017 FPL for a two-person household.

Therefore, NYSOH improperly determined that you were in a one-person household for the purposes of determining your eligibility on March 5, 2018.

Since the March 6, 2018 eligibility redetermination notice was based on an incorrect household size, it is RESCINDED.

You testified that your annual expected income is now \$29,577.60. You further testified that this was your actual expected income as of your March 5, 2018 application, although you were not aware that you had received a raise increasing your income at that time. Therefore, your case is RETURNED to NYSOH for a redetermination of your eligibility based on a two-person

household, residing in Westchester County, with an annual income of \$29,577.60, and to notify you accordingly.

Decision

The March 6, 2018 eligibility redetermination notice is RESCINDED.

Your case is RETURNED to NYSOH for a redetermination of your eligibility based on a two-person household, residing in Westchester County, with an annual income of \$29,577.60, and to notify you accordingly.

How this Decision Affects Your Eligibility

You are ineligible for APTC and cost-sharing reductions.

This is not a final determination of your eligibility for financial assistance. Your case is being sent back to NYSOH for a redetermination of your eligibility based on a two-person household, residing in Westchester County, with an annual income of \$29,577.60.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
