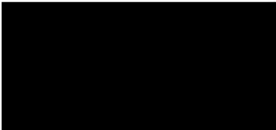

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your daughter did not qualify to select a new qualified health plan outside of the open enrollment period?

Procedural History

On October 29, 2017, NY State of Health (NYSOH) issued a renewal notice, stating that, based on the information from federal and state sources, NYSOH could not make a decision about whether your daughter qualified for financial help paying for her health insurance. The notice further stated that you had to update the information in your NYSOH account by December 15, 2017, so NYSOH could make an appropriate decision.

On November 24, 2017, you submitted an updated application for financial assistance with health insurance through NYSOH.

On November 25, 2017, NYSOH issued an eligibility redetermination notice, based on your November 24, 2017 application, stating that your daughter was eligible for a tax credit up to \$0.00 per month to help pay for her health coverage, as well as cost-sharing reductions if she enrolled in a silver level qualified health plan, both effective January 1, 2018.

Also on November 25, 2017, NYSOH issued an enrollment confirmation notice, based on your plan selection made November 24, 2017 stating that your

daughter was enrolled in a child only plan with premium tax credits, with a start date of January 1, 2018.

On March 9, 2018, you submitted an updated application for financial assistance with health insurance through NYSOH. That same day, you attempted to change your daughter's qualified health plan, but you were unable to.

Also on March 9, 2018, you spoke to NYSOH's Account Review Unit and appealed insofar as your daughter was not eligible to select a new qualified health plan outside of the open enrollment period.

On March 10, 2018, NYSOH issued an eligibility redetermination notice, based on your March 9, 2018 application, stating that your daughter did not qualify to select a health plan outside of open enrollment period for 2018, effective April 1, 2018.

On May 11, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking for your daughter to be eligible for a special enrollment period in order to change health plans.
- 2) On November 24, 2017, you submitted an application for health insurance, and enrolled you daughter into a qualified health plan the same day. You selected this plan online, without assistance from NYSOH.
- 3) You testified that, when deciding which plan to pick, you compared them all, including looking to see if prescriptions were covered, but that you must have missed that the plan you selected had a \$4,000.00 deductible before prescriptions would be covered.
- 4) On November 25, 2017, NYSOH issued an enrollment confirmation notice, based on your plan selection on November 24, 2017. That noticed stated that your daughter was enrolled in a bronze level child only plan with premium tax credits. The notice further stated that the plan included an annual deductible of \$4,000.00.
- 5) You testified that you received the November 25, 2017 enrollment confirmation notice.

- 6) You testified that you first became aware of the \$4,000.00 annual deductible in the first week of January 2018.
- 7) On March 9, 2018, you attempted to select a new qualified health plan for your daughter, because you could not afford to pay down the deductible for prescriptions. You were unable to change plans at that time.
- 8) You testified that you did not attempt to change your daughter's plan prior to March 9, 2018 because you were handling other issues and that you would have contacted NYSOH earlier but that "life got in the way."
- 9) You testified that since filing your application on November 24, 2017 there have been no other major changes to your household.
- 10) You testified that you did not rely on any statements made by NYSOH when originally selecting your daughter's health plan for 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a QHP and enrollees may change QHPs (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2018, the national annual open enrollment period began on November 1, 2017 and extended through December 15, 2017 (45 CFR § 155.410(e)(3)). NY State extended this enrollment period through January 31, 2018 for applications processed through NYSOH (https://www.health.ny.gov/press/releases/2017/2017-09-07_open_enrollment_dates.htm).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:

- (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
- (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.
- (3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.
- (4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.
- (5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;
- (6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.
- (7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your daughter did not qualify to enroll in a qualified health plan outside of the open enrollment period.

NYSOH provided an open enrollment period from November 1, 2017 until January 31, 2018. On November 24, 2017, you submitted an application for health insurance and enrolled your daughter in a qualified health plan that same day. On March 9, 2018, you attempted to change your daughter's qualified health plan but she did not qualify to select a new qualified health plan outside of the open enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified that, when you selected a plan for your daughter to enroll in, you did not rely on any statements made by NYSOH nor did NYSOH make any representations that turned out to be untrue. You further testified that you attempted to compare all of the plans but that you must have missed that the plan you selected had a \$4,000.00 annual deductible. However, after you enrolled your daughter in her plan, NYSOH issued an enrollment confirmation notice that stated that the plan had a \$4,000.00 annual deductible and you testified that you received this notice. Since the record does not indicate that

NYSOH, by action or inaction, made an error or misrepresented information, a special enrollment period cannot be granted.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2018, no triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's March 10, 2018 eligibility redetermination notice that you do not qualify to select a health plan outside of the open enrollment period for 2018 is **AFFIRMED**.

Decision

The March 10, 2018 eligibility redetermination notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

Your daughter does not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
