Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, as of January 31, 2018?

Did NYSOH properly determine that you were ineligible for Medicaid as of January 31, 2018?

Procedural History

On January 30, 2018, you submitted a financial assistance application through NYSOH.

On January 31, 2018, NYSOH issued an eligibility determination notice stating, in relevant part, that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective March 1, 2018. The notice also stated that you were ineligible for Medicaid because your income exceeded the income threshold for that program.

Also on January 31, 2018, NYSOH issued a plan enrollment notice confirming, in relevant part, that as of January 30, 2018, you were enrolled in an Essential Plan with an enrollment start date of March 1, 2018.

Also on March 12, 2018, you spoke to NYSOH's Account Review Unit and requested an appeal relative to the amount of financial assistance you were determined eligible to receive.

On May 14, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- You testified that you were only appealing the amount of financial assistance that you were determined eligible to receive.
- 2) According to your NYSOH account and testimony, you expect to file a 2018 federal income tax return with the tax status of Head of Household (with qualifying individual), and you expect to claim your child as a dependent on that return.
- 3) According to your January 30, 2018 application, you were employed at Your wage rate was \$13.00 per hour, and you worked 40 hours per week. Based on that attestation, your annual household income was calculated to be \$27,040.00.
- 4) You testified that, as of April 2018, you were no longer working at and began working at Further, your wage rate is \$13.00 per hour and you work on average 42 hours per week.
- 5) According to your NYSOH account and testimony, you do not expect to claim any deductions on your 2018 federal income tax return.
- 6) According to your NYSOH account, you reside in York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)).

Household Composition

For the Essential Plan, the household size equals the number of individuals for whom the taxpayers are allowed a deduction under 26 USC § 151 for the taxable year, which typically includes: (1) the taxpayer, (2) his or her spouse, and (3) any claimed dependents (26 USC § 36B(d)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Federal Register 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see https://www.medicaid.gov/basic-health-program.html).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2018 FPL, which is \$16,460.00 for a two-person household (83 Fed. Reg. 2642).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan with a \$20.00 premium per month, as of January 31, 2018.

On January 30, 2018, you submitted an application for financial assistance through NYSOH. In that application, you attested to an expected annual household income of \$27.040.00, and the January 31, 2018, eligibility determination relied upon that information.

For an individual who expects to file a federal income tax return, the household equals the taxpayers and the number of individuals for whom the taxpayer is claiming as a dependent.

You attested that you expect to file a 2018 federal income tax return with the tax status of Head of Household (with qualifying individual), and expect to claim your child as a dependent on that return. Therefore, you were in a two-person household.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. An individual who has a household income above 150% of the FPL will have a \$20.00 monthly premium contribution

On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since an annual household income of \$27,040.00 is 166.50% of the 2017 FPL, NYSOH properly found you to be eligible for the Essential Plan, with a monthly premium of \$20.00.

The second issue under review is whether NYSOH properly determined you to be ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,460.00 for a two-person household.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,893.00 monthly for a two-person household.

The record reflects that as of January 31, 2018, you were employed at Further, your wage rate was \$13.00 per hour, and you worked 40 hours per week. Based on that attestation, your annual household income was calculated to be \$27,040.00.

Therefore, your monthly income of (\$27,040.00 / 12 months) is \$2,253.33 and exceeded the maximum allowable monthly income amount of \$1,893.00, such that you did not qualify for Medicaid.

The January 31, 2018 eligibility determination notice properly stated that, based on the information you provided, you were eligible to enroll in the Essential Plan, with a \$20.00 monthly premium, and were ineligible for Medicaid. Therefore, it is correct and AFFIRMED.

You testified	d that, in April 2018, you no longer worked at	and began
working at	. Further, your wage rate is \$13.00 p	er hour and you

work on average 42 hours per week. Therefore, your annual household income is (42 hours X \$13.00 X 52 weeks) \$28,392.00.

Since this change in income will not materially affect your eligibility for financial assistance through NYSOH, your case will not be returned to NYSOH to redetermine your eligibility for financial assistance.

Decision

The January 31, 2018 eligibility determination notice is AFFIRMED.

This decision does not change your eligibility for or enrollment in health insurance coverage through NYSOH.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
