NOTICE OF DISMISSAL – FAILURE TO APPEAR

On March 13, 2018, NY State of Health (NYSOH) issued a plan enrollment notice, stating that your enrollment in the Essential Plan began April 1, 2018. You appealed this determination.

On April 16, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 8, 2018, at 3:00 p.m.

On May 8, 2018, a Hearing Officer called you at 3:00 p.m. but was unable to reach you. The Hearing Officer call you again at 3:15 p.m. Although you answered the call, you requested the Hearing Officer call you at a later time or date. The Hearing Officer agreed to call you at 3:30 p.m. but declined to adjourn your hearing to a different date. The Hearing Officer called you at the agreed upon time of 3:30 p.m. but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
