Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly enroll your children in a Child Health Plus plan with an enrollment start date of April 1, 2018?

Procedural History

On February 12, 2018, you submitted an application for financial assistance through NYSOH.

On February 13, 2018, NYSOH issued an eligibility determination notice stating, in relevant part, that your children were eligible for Child Health Plus, each with a monthly premium of \$9.00, effective March 1, 2018. Further, the notice instructed you to choose a health plan, and you would receive written confirmation from NYSOH once a plan was selected.

On March 6, 2018, NYSOH issued a plan enrollment notice confirming that as of March 5, 2018, your children were enrolled in a Child Health Plus plan with an enrollment start date of April 1, 2018.

On March 13, 2018, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the enrollment start date of your children's Child Health Plus coverage.

On May 14, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, your children were born on [REDACTED] and [REDACTED].
- 2) You testified that your username through NYSOH is [REDACTED].”
- 3) According to your NYSOH account, on February 12, 2018, you accessed your account and applied for health insurance for your children. No health plan was selected for your children on that date.
- 4) You testified that before applying for health insurance through NYSOH, your children were enrolled in a Child Health Plus plan through Excellus.
- 5) You further testified that, in the past, you did not have to reenroll your children in a plan when their coverage was renewed.
- 6) You testified that you do not recall if you received a notice from NYSOH instructing you to select a health plan for your children.
- 7) According to your NYSOH account and testimony, you receive notices from NYSOH by regular mail through the United States Postal Service (USPS).
- 8) According to your NYSOH account, none of the notices that were issued by NYSOH were returned as undeliverable.
- 9) According to your NYSOH account, your children were enrolled in a Child Health Plus plan on March 5, 2018.
- 10) You testified that you have outstanding medical expenses for the month of March 2018, and want your children's health plan to be backdated to cover those medical expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus – Effective Date

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly enrolled your children in a Child Health Plus plan with an enrollment start date of April 1, 2018.

The record reflects that on February 12, 2018, you accessed your NYSOH account and submitted an application for financial assistance for your children. Based on that application, your children were determined eligible to enroll in a Child Health Plus plan.

You testified that before applying for health insurance through NYSOH your children were enrolled in a Child Health Plus plan through Excellus. You further testified that you did not have to reenroll your children in a plan when their coverage was renewed in the past.

On February 13, 2018, NYSOH issued an eligibility determination notice stating, in relevant part, that your children were eligible for Child Health Plus, each with a monthly premium of \$9.00, effective March 1, 2018. Further, the notice instructed

you to choose a health plan, and you would receive written confirmation from NYSOH once a plan was selected.

You testified that you did not recall if you received a notice from NYSOH instructing you to select a health plan for your children. The record reflects that you receive notices from NYSOH by regular mail through the USPS. There is no evidence in the record that any of the notices that were sent to your mailing address were returned to NYSOH as undeliverable. Therefore, it is reasonable to conclude that NYSOH sent you proper notice to select a Child Health Plus plan for your children's coverage to start.

The date on which enrollment in a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

The record reflects that you selected the Child Health Plus plan on March 5, 2018. Since the health plan was selected on March 5, 2018, coverage in that health plan properly began on the first day of the following month; that is, on April 1, 2018.

Therefore, the March 6, 2018 plan enrollment notice is AFFIRMED.

Decision

The March 6, 2018 plan enrollment notice is AFFIRMED.

Your children were enrolled in a Child Health Plus plan with an enrollment start date of April 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
