

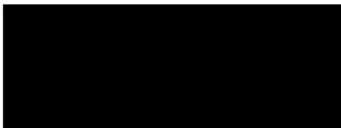

## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

Dear [REDACTED],

On March 14, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for a full pay qualified health plan through NYSOH, effective April 1, 2018. You appealed this determination.

On April 17, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 11, 2018 at 11:00 a.m..

On May 11, 2018, a Hearing Officer placed a telephone call to the telephone number that you provided to NYSOH, at 11:00 a.m., and no one answered.

The Hearing Officer placed another call at 11:15 a.m.. After answering the phone, you informed the Hearing Officer that now was not a good time. The Hearing Officer asked if you would be available at 11:30 a.m.. You stated that you would be available at 11:30 a.m.. As a result, the Hearing Officer placed a telephone call to the telephone number that you provided to NYSOH at 11:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
