NOTICE OF DISMISSAL

On March 14, 2018, NY State of Health (NYSOH) issued an enrollment notice confirming your enrollment in an Essential Plan, effective April 1, 2018. You appealed this notice.

On April 17, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 9, 2018, at 11:00 a.m.

A Hearing Officer called you at 11:00 a.m. and again at 11:15 a.m. on May 9, 2018. Although you answered the call at 11:15 a.m., you stated you could not speak right now because you were at a very important appointment and asked that you be called back in an hour. The Hearing Officer responded they could not call you back in an hour because your hearing was scheduled for 11:00 a.m. You stated you no longer required a hearing because you were found eligible for Medicaid. The Hearing Officer offered to withdraw your appeal request formally on the record if you no longer required a hearing on the issue of the start date of your Essential Plan. You explained you could not speak any longer and that your appointment was very important. The Hearing Officer stated they would be sending notification to you that you could not proceed with the hearing that day and your case would be dismissed. The call was then ended.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
