

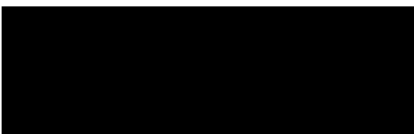

Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$292.00 per month in advance payments of the premium tax credit (APTC)?

Did NYSOH properly determine that you were ineligible for cost-sharing reductions (CSR)?

Did NYSOH properly determine that you were ineligible for the Essential Plan?

Procedural History

On March 15, 2018, you submitted an application for financial assistance through NYSOH. Based on that application, NYSOH rendered a preliminary eligibility determination notice stating that you were eligible to receive up to \$292.00 monthly of APTC.

Also on March 15, 2018, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the amount of financial assistance you were determined eligible to receive.

On March 16, 2018, NYSOH issued an eligibility determination notice stating that you were eligible for up to \$292.00 monthly of APTC, effective as of April 1,

2018. The notice also stated that you were ineligible for CSR and the Essential Plan because your income exceeded the income threshold for those programs.

On May 16, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was left open to allow you to submit your 2017 Form 1040, U.S. Individual Income Tax Return, or 2017 Form 1098-E Student Loan Interest Statement to NYSOH's Appeals Unit.

On May 18, 2018, you faxed four-pages of documentation to NYSOH's Appeals Unit. That documentation was made part of the record as "[REDACTED]". The record is complete and closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and testimony, you are applying for health insurance for yourself.
- 2) According to your March 15, 2018 application, you attested that you expected to earn \$31,200.00 in 2018.
- 3) According to your March 15, 2018 application and testimony, you expect to file a 2018 federal income tax return with the tax status of single, and do not expect to claim any dependents on that tax return.
- 4) According to your NYSOH account, you do not expect to claim any deductions on your 2018 federal income tax return.
- 5) You testified that you want your living expenses and child support payments to be considered when NYSOH determines your eligibility for financial assistance.
- 6) You testified that you are currently making payments on your student loans; however, you were not aware how much of the payments were being applied to the interest portion of the loan.
- 7) On May 18, 2018, you submitted your 2017 Form 1040, U.S. Individual Income Tax Return, to NYSOH's Appeals Unit. Line 33 of that return reflects that you did not claim any student loan interest deduction in 2017 (see [REDACTED]).
- 8) According to your NYSOH account, you reside in [REDACTED], New York.

- 9) You testified you are unable to afford the health insurance premiums based on the amount of financial assistance you were determined eligible to receive.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)).

Subject to limitations, there shall be allowed as a deduction from the adjusted gross income, an amount not to exceed \$2,500.00, equal to the interest paid by the taxpayer during the taxable year on any qualified education loan (26 USC § 221; IRS Publication 970 (2017)).

“A payment that is specifically designated as child support or treated as specifically designated as child support under your divorce or separation instrument isn’t alimony. The amount of child support may vary over time. Child support payments aren’t deductible by the payer and aren’t taxable to the payee” (Internal Revenue Service (IRS) Publication 504 (2017)).

Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (26 USC § 262(a)).

Household Composition

For APTC and CSR, the household size equals the number of individuals for whom the taxpayers are allowed a deduction under 26 USC § 151 for the taxable

year, which typically includes: (1) the taxpayer, (2) his or her spouse, and (3) any claimed dependents (26 USC § 36B(d)(1)).

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

For annual household income in the range of at least 250% but less than 300% of the 2017 FPL, the expected contribution in 2018 is between 8.10% and 9.56% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may

get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Affordability Exemption

Under some circumstances, a person may receive an exemption from paying a penalty for not purchasing health insurance coverage. Such an exemption may be granted if that person can show that he or she experienced a financial hardship or has domestic circumstances that (1) caused an unexpected increase in essential expenses that prevented that person from obtaining health coverage under a QHP; (2) would have caused the person to experience serious deprivation of food, shelter, clothing, or other necessities, as a result of the expense of purchasing health coverage under a QHP; or (3) prevented that person from obtaining coverage under a QHP (45 CFR § 155.605(a), (g)).

NY State of Health has deferred to the U.S. Department of Health and Human Services (HHS) on the matter of hardship exemptions (see 45 CFR § 155.505(c)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for up to \$292.00 of APTC per month.

Based on the application that was submitted on March 15, 2018, you attested to an expected 2018 annual household income of \$31,200.00, and the March 16, 2018 eligibility determination relied upon that information.

For an individual who expects to file a federal income tax return, the household equals the taxpayers and the number of individuals for whom the taxpayer is claiming as a dependent.

You attested that you expect to file a 2018 federal income tax return with the tax status of single, and do not expect to claim any dependents on that return. Therefore, you were in a one-person household for purposes of this analysis.

You reside in [REDACTED], New York, where the second lowest cost silver plan available for an individual through NYSOH costs \$509.30 per month.

An annual income of \$31,200.00 is 258.71% of the 2017 FPL for a one-person household. At 258.71% of the 2017 FPL, the expected contribution is 8.35% of the household income, or \$217.10 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$509.30 per month) minus your expected contribution (\$140.36 per month), which equals \$292.20 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$292.00 per month in APTC.

The second issue under review is whether you were properly found eligible for CSR.

CSR are available to a person who has a household income no greater than 250% of the 2017 FPL. Since a one-person household with an income of \$31,200.00 is 258.71% of the 2017 FPL, NYSOH correctly found you to be ineligible for CSR.

The third issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since an annual household income of \$31,200.00 is 258.71% of the 2017 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

Since the March 16, 2018 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$292.00 per month in APTC, ineligible for CSR, and ineligible for the Essential Plan, it is correct and is AFFIRMED.

You testified that you want your living expenses and child support payments to be considered when NYSOH determines your eligibility for financial assistance. These expenses cannot be considered when an individual's adjusted gross income is calculated and, therefore, were not computed when NYSOH calculated your eligibility for financial assistance.

You testified that you are currently making payments on your student loans; however, you were not aware how much of the payments were being applied to the interest portion of the loan. On May 18, 2018, you submitted your 2017 Form 1040 U.S. Individual Income Tax Return to NYSOH's Appeals Unit. Line 33 of that return reflects that you did not claim any student loan interest deduction in 2017 (██████████). Therefore, the record does not have sufficient evidence to return your case to NYSOH to recalculate your eligibility for financial assistance.

Decision

The March 16, 2018 eligibility determination notice is AFFIRMED.

You were properly determined eligible for up to \$292.00 monthly in APTC.

You were properly determined ineligible for CSR and the Essential Plan.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
