Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your child's eligibility and enrollment in his Child Health Plus plan was effective April 1, 2018?

Procedural History

On February 28, 2018, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your February 27, 2018 application, stating that your child was eligible to enroll in Child Health Plus at full cost, effective April 1, 2018.

Also on February 28, 2018, NYSOH issued a notice of enrollment, based on your plan selection on February 27, 2018, stating that your child was enrolled in a Child Health Plus plan, and that this enrollment in the plan would start April 1, 2018.

On March 15, 2018, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin February 1, 2018.

On May 9, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's enrollment start date.
- 2) You submitted your household's initial application to NYSOH for financial assistance on February 27, 2018.
- 3) You testified, and the record reflects, that you enrolled your child into a Child Health Plus plan on February 27, 2018.
- 4) You testified that you need your child's Child Health Plus plan to begin on February 1, 2018 because you and your spouse's health plan began on February 1, 2018 and your child incurred substantial medical bills in the month of March 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g.

State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your child's eligibility and enrollment in his Child Health Plus plan was effective April 1, 2018.

You testified and your account confirms that you applied for health insurance coverage for your entire household online on February 27, 2018. You and your spouse were able to enroll in a plan, effective February 1, 2018.

However, the date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you first applied for and selected a Child Health Plus plan for enrollment on February 27, 2018; that coverage would have properly begun on the first day of the second following month after February, that is as of April 1, 2018.

Therefore, the February 28, 2018 eligibility determination and enrollment confirmation notices stating that your child's eligibility and enrollment in his Child Health Plus plan was effective April 1, 2018, is correct and must be AFFIRMED.

Decision

The February 28, 2018 eligibility determination and enrollment confirmation notices are AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is April 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
