## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a dental plan was effective April 1, 2018?

## Procedural History

On July 21, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, effective September 1, 2017.

On August 3, 2017, NYSOH issued an enrollment confirmation notice stating that you were enrolled in a medical only Essential Plan with a plan enrollment start date of September 1, 2017.

On March 16, 2018, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in a dental plan with a plan enrollment start date of April 1, 2018.

Also on March 16, 2018 you spoke to NYSOH's Account Review Unit and appealed insofar as your dental plan began on April 1, 2018, and not March 1, 2018.

On May 14, 2018, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date.

On May 17, 2018, you had an adjourned hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to formal notice of the hearing. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking to have your dental plan enrollment begin on March 1, 2018 rather than April 1, 2018.
- 2) According to your NYSOH account, on August 2, 2017, you were enrolled in a medical only Essential Plan with an enrollment start date of September 1, 2017.
- 3) You testified that you believe you contacted NYSOH to enroll in a dental plan at the same time you filed your request for an appeal in March 2018.
- 4) Your NYSOH account reflects that on March 15, 2018 you contacted NYSOH and selected a dental plan for enrollment and that on March 16, 2018 you requested to appeal your dental plan enrollment start date.
- 5) Your enrollment in your dental plan became effective April 1, 2018.
- 6) You testified that you contacted NYSOH to enroll in dental coverage because you were having [REDACTED] and were concerned that you would have to go to the dentist, however, you did not have to go to the dentist in March 2018 and have no outstanding dental bills at this time.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Stand-Alone Dental Plans

If a stand-alone dental plan is offered through NYSOH, NYSOH must not fail to treat the dental plan as QHP solely because the plan does not offer the same coverage of benefits (45 CFR §155.1065(a), (d)).

## QHP Enrollment Start Date

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your enrollment in a dental plan was effective April 1, 2018.

On August 2, 2017, you were enrolled in a medical only Essential Plan, with an enrollment start date of September 1, 2017.

The record reflects that you contacted NYSOH to enroll in a dental plan on March 15, 2018. The following day, NYSOH issued an enrollment notice confirming that you were enrolled in a dental plan with a plan enrollment start date of April 1, 2018.

The date on which a qualified health plan or stand-alone dental plan can take effect depends on the day a person selects the plan for enrollment. If the plan is selected from the first day to the fifteenth day of a month, the plan is effective on the first day of the following month. If the plan is selected from the sixteenth day of the month to the end of the month, the plan is effective on the first day of the second following month.

On March 15, 2018, you selected a dental plan, so your enrollment properly took effect on the first day of the first month following March 2018; that is, on April 1, 2018.

Therefore, the March 16, 2018 enrollment confirmation notice stating that your enrollment in your dental plan was effective April 1, 2018, is correct and must be **AFFIRMED**.

## **Decision**

The March 16, 2018 enrollment confirmation notice is **AFFIRMED**.

### **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

Your dental plan properly began as of April 1, 2018.

### **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
