

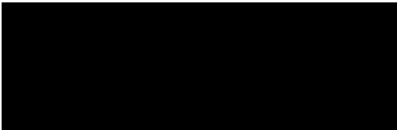

NOTICE OF DISMISSAL – FAILURE TO APPEAR

On March 17, 2018, NY State of Health (NYSOH) issued a notice of enrollment confirmation stating that your [REDACTED] was reenrolled in her Medicaid Managed Care plan, effective May 1, 2018. You appealed this determination.

On April 19, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 14, 2018, at 1:00 pm.

On May 14, 2018, a Hearing Officer called you and you requested that day that your hearing be adjourned. The Hearing Officer granted your request and your hearing was adjourned to May 23, 2018 at 2:00 pm.

On May 23, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 2:00 pm, 2:15 pm, and 2:30 pm, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
