## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Was your Essential Plan properly terminated on February 28, 2018, because you did not pay your insurance bill by the payment deadline?

Did NY State of Health (NYSOH) properly determine that your Essential Plan had a plan enrollment start date of April 1, 2018?

## Procedural History

On November 17, 2017, NYSOH issued a plan enrollment notice confirming that as of November 16, 2017, you were enrolled in an Essential Plan with an enrollment start date of January 1, 2018.

On March 9, 2018, NYSOH issued a disenrollment notice stating that your Essential Plan would end on February 28, 2018, because you did not pay your insurance bill by the payment deadline.

On March 10, 2018, NYSOH issued a plan enrollment notice confirming that as of March 9, 2018, you were enrolled in an Essential Plan with an enrollment start date of April 1, 2018.

On March 16, 2018, you spoke to NYSOH's Account Review Unit and requested an appeal insofar as you were not enrolled in an Essential Plan for the month of March 2018.

On May 14, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you were enrolled in an Essential Plan, through Healthfirst, with an enrollment start date of January 1, 2018.
- 2) You testified that you were enrolled in Healthfirst health insurance plans for the last two years, during which time the premiums were automatically withdrawn from your bank account.
- 3) You testified that the January 2018 and February 2018 health insurance premiums were not paid because they were not automatically withdrawn from your bank account.
- 4) According to your NYSOH account, on March 8, 2018, the plan initiated termination of your coverage.
- 5) You testified that you found out that your coverage was terminated when you received the March 9, 2018 disenrollment notice from NYSOH.
- 6) According to your NYSOH account, on March 9, 2018, you reenrolled in an Essential Plan.
- 7) You testified that you did not receive a final notice of premium payment from Healthfirst until March 23, 2018.
- 8) You testified that you incurred medical bills in March 2018, and you want your Essential Plan coverage to be effectuated March 1, 2018, to cover those medical expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax

credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The first issue under review is whether your enrollment in your Essential Plan properly ended February 28, 2018, because you did not pay your insurance bill by the payment deadline.

The record reflects that you enrolled in an Essential Plan through Healthfirst, effective January 1, 2018.

You testified that you were enrolled in Healthfirst health insurance plans for the last two years. For the last two years the premiums were automatically withdrawn from your bank account. However, the January 2018 and February 2018 health insurance premiums were not paid because they were not automatically withdrawn from your bank account.

On March 8, 2018, the Healthfirst initiated termination of your coverage. On March 9, 2018, NYSOH issued you a disenrollment notice stating that your coverage would end February 28, 2018, because you did not pay your insurance bill by the payment deadline.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether you were properly terminated from your Essential Plan for nonpayment of premiums. Therefore, your appeal of the March 9, 2018 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that you were enrolled in an Essential Plan with an enrollment start date of April 1, 2018.

The record reflects that, on March 9, 2018, you were reenrolled in an Essential Plan.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

The record reflects that you selected an Essential Plan for re-enrollment on March 9, 2018, so your enrollment properly took effect on the first day of the following month; that is, on April 1, 2018.

Therefore, the March 10, 2018 plan enrollment notice is **AFFIRMED**.

## **Decision**

Your appeal of the March 9, 2018 disenrollment notice is **DISMISSED** as a non-appealable issue.

The March 10, 2018 plan enrollment notice is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

The enrollment start date of your Essential Plan is April 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
