NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On February 17, 2018, NY State of Health (NYSOH) issued a discontinuance and disenrollment notice stating that you were no longer eligible for health insurance through NSYOH, effective March 1, 2018. This was because notices regarding your eligibility and coverage sent to you by NYSOH were returned as undeliverable. You appealed that determination.

On May 18, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

The Hearing Officer placed you under oath. You identified yourself and made a brief statement. You verified your address, and testified that you have received mail from NYSOH in the past and continue to receive mail from NYSOH. You further testified that you would like NYSOH to contact you prior to disenrolling you for returned mail.

Finally, you testified that you were no longer interested in pursuing your appeal because your re-enrollment began on May 1, 2018 and you do not have any outstanding claims for the months of March 2018 or April 2018.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
