NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On March 22, 2018, NY State of Health (NYSOH) issued discontinuance and disenrollment notices, stating that your spouse was no longer eligible insurance through NYSOH effective April 1, 2018, and was disenrolled from her qualified health plan effective March 31, 2018. You appealed your spouse's disenrollment, and sought to have your spouse's coverage reinstated effective April 1, 2018.

On May 15, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your spouse had been reinstated in her qualified health plan, effective May 1, 2018, and the appeal was therefore moot.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
