Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan (QHP) and the application of advance payments of the premium tax credit (APTC) were effective June 1, 2018?

Procedural History

On May 1, 2018, you updated your NYSOH account.

On May 2, 2018, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$290.00 per month in APTC. This eligibility was effective June 1, 2018.

On May 9, 2018, you selected a plan for enrollment.

Also on May 9, 2018, you spoke to NYSOH's Account Review Unit and appealed the fact that your enrollment in your QHP, with APTC applied, became effective on June 1, 2018, and not May 1, 2018.

On May 10, 2018, NYSOH issued a notice confirming your enrollment in a QHP with a monthly premium responsibility of \$241.11, after your APTC of \$290.00 was applied, both effective June 1, 2018.

On May 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You applied to NYSOH for financial assistance with health insurance on May 1, 2018.
- 2) You were determined eligible to receive up to \$290.00 per month in APTC. This eligibility was effective June 1, 2018.
- 3) You testified, and the record reflects, that you selected a qualified health plan on May 9, 2018.
- 4) Your enrollment in the plan became effective June 1, 2018.
- 5) You testified that you would like your QHP with APTC to begin on May 1, 2018 because you have medical procedures which need to be completed during May 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Redetermination During a Benefit Year

When a redetermination is issued because of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be that any change made after the 15th of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a QHP, as well as the application of APTC, was effective June 1, 2018.

The record shows that May 1, 2018 you updated the information in your NYSOH account. You were determined eligible to receive up to \$290.00 per month in APTC, effective June 1, 2018. You submitted a request to enroll in a QHP on May 9, 2018. On May 10, 2018, NYSOH issued an enrollment confirmation notice stating that your enrollment in your QHP was effective June 1, 2018 and that APTC would be applied to your monthly premium effective June 1, 2018.

When an individual's eligibility to enroll in a QHP changes, NYSOH will generally make the redetermination that results from the change effective the first day of the following month if the change occurs on or before the 15th of the month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is after the fifteenth day of a month goes into effect on the first day of the second following month.

You updated your application on May 1, 2018. You testified that you selected your QHP on May 9, 2018. As such, your eligibility for and enrollment in a QHP, as well as the application of APTC, properly took effect on the first day of the next month; that is, on June 1, 2018.

Therefore, NYSOH's May 2, 2018 eligibility determination notice and May 10, 2018 enrollment confirmation notices are **AFFIRMED** because they properly began your enrollment in your QHP as well as your APTC on June 1, 2018.

Decision

The May 2, 2018 eligibility determination notice is **AFFIRMED**.

The May 10, 2018 enrollment confirmation notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

Your enrollment in your QHP, and your eligibility for APTC properly began as of June 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
