Issue

The issues presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your qualified health plan ended effective January 1, 2017?

Procedural History

On November 25, 2015, NYSOH issued an enrollment notice confirming your enrollment in a Platinum level qualified health plan effective January 1, 2016.

On December 27, 2016, you contacted the NYSOH Account Review Unit and appealed the date you were disenrolled from your qualified health plan, requesting the disenrollment be made effective August 1, 2016, not January 1, 2017.

On December 28, 2016 NYSOH issued a disenrollment notice indicating that coverage in your qualified health plan would end effective January 1, 2017.

On March 29, 2017, you had a telephone hearing with a Hearing Officer from the NYSOH's Appeals Unit. During the hearing, your mother [REDACTED], offered testimony on your behalf. The record was developed during the hearing and closed at the end of the proceeding.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You were enrolled in a platinum level qualified health plan, effective January 1, 2016.
- 2) Your mother testified that you became eligible for insurance through your school on August 1, 2016.
- 3) Your mother testified you contacted NYSOH in August, 2016 to disenroll yourself from your qualified health plan through NYSOH. She was not sure of the exact date you placed the phone call.
- 4) Your mother testified that she did not pay premium payments for your qualified health plan for the months of August through December, 2016.
- 5) Your mother testified that you did not use your qualified health plan in the months of August through December, 2016.
- 6) On December 27, 2016, an official complaint was filed requesting retroactive disenrollment from your qualified health plan (Tracking [REDACTED]).
- 7) Your mother testified you are seeking retroactive disenrollment from your qualified health plan effective August 1, 2016.
- 8) The enrollment history tab in your NYSOH account shows your enrollment in your qualified health plan ended effective July 31, 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Termination of a Qualified Health Plan

NYSOH must permit an enrollee to terminate his or her coverage with a qualified health plan coverage, with appropriate notice to the NYSOH or qualified health plan (45 CFR § 155.430(b)(1)(i)).

For enrollee-initiated terminations, the last day of coverage is either:

- 1) The termination date specified by the enrollee, if the enrollee provides reasonable notice (at least 14 days before the requested termination date);
- 2) Fourteen days after the enrollee requests the termination, if they do not provide reasonable notice; or
- 3) On a date on or after the date the enrollee requests the termination, if the enrollee's qualified health plan issuer and the enrollee agree to such a date

(45 CFR § 155.430(d)(2)(i)-(iii)).

NYSOH must permit an enrollee to retroactively terminate or cancel their enrollment in a qualified health plan if:

- 1) The enrollee demonstrates that they attempted to terminate their coverage and experienced a technical error that did not allow the coverage to be terminated, and requests retroactive termination within 60 days after they discovered the technical error.
- 2) The enrollment in the qualified health plan was unintentional, inadvertent, or erroneous and was the result of the error or misconduct of an officer, employee, or agent of NYSOH or HHS, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities. Such enrollee must request cancellation within 60 days of discovering the unintentional, inadvertent, or erroneous enrollment.
- 3) The enrollee was enrolled in a qualified health plan without their knowledge or consent by any third party, including third parties who have no connection with the Exchange, and requests cancellation within 60 days of discovering of the enrollment.

(45 CFR § 155.430(b)(2)(iv)(A-C)).

NYSOH permits a qualified health plan to terminate an individual's coverage if (1) the enrollee is no longer eligible for coverage or (2) non-payment of the premiums by the enrollee (45 CFR § 155.430(b)(2)(i)-(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your qualified health plan ended effective January 1, 2017.

You were enrolled in a platinum level qualified health plan, effective January 1, 2016, as confirmed in an enrollment confirmation notice issued November 25, 2016.

Your mother testified that you became eligible for insurance through your school on August 1, 2016 and that you contacted NYSOH in August, 2016 to disenroll yourself from your qualified health plan through NYSOH.

However, there is no indication in the record that you contacted NYSOH in August 2016. The first time a complaint was filed in requesting the termination of your qualified health plan was on December 27, 2016.

On December 28, 2016 NYSOH issued a disenrollment notice indicating that coverage in your qualified health plan would end effective January 1, 2017.

Your mother testified you are seeking retroactive disenrollment from your qualified health plan effective August 1, 2016.

The enrollment history tab in your NYSOH account shows your enrollment in your qualified health plan ended effective July 31, 2016. Since NYSOH's record indicates that your enrollment in your Platinum level qualified health plan ended effective July 31, 2016, a discussion of the merits of your case is not necessary.

Therefore, the December 28, 2016 disenrollment notice is MODIFIED to reflect your enrollment in your Platinum level qualified health plan ended July 31, 2016.

Decision

The December 28, 2016 disenrollment notice is MODIFIED to reflect your enrollment in your Platinum level qualified health plan ended July 31, 2016.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
